### Handling Fee

Payment is subject to the following system fees

Amount	Handling Fee
10,000 yen or less	100 yen(+ Tax)
20,000 yen or less	200 yen(+ Tax)
30,000 yen or less	300 yen(+ Tax)
40,000 yen or less	400 yen(+ Tax)
40,001 yen or more	100 yen added for each additional 10,000 yen
